ENERGY STAR Freezer (min. 10 cu ft)	\$25

Eligible HVAC Systems	Rebate
High Efficiency Heat Pump or Mini-Split (16 SEER or greater)	\$150
Geothermal Heat Pump (19 SEER or greater)	\$250

### Rebate Requirements

- New freezer and refrigerator must be ENERGY STAR qualified and meet minimum size requirements.
- When replacing an existing central AC or heat pump unit, the old unit must not have a seasonal energy efficiency ratio (SEER) greater than 13.
- When replacing an existing geothermal unit, the old unit must not have an energy efficiency ratio (EER) greater than 17.

### REBATE PROCESS

- Submit the following information for refrigerator/freezer rebate:
  - Completed rebate form
  - Copy of detailed receipt with model number
  - Energy Guide label with ENERGY STAR symbol.
- Submit the following information after work is completed for heat pump:
  - Completed rebate form
  - Copy of detailed invoice with seasonal energy efficiency ratio (SEER).
  - Copy of AHRI Certificate of Product Rating (contractor can provide this certificate upon request).



### ELIGIBILITY

- Applicant must be member of record for an active Blue Ridge Energy electric account (under eligibility).
- Rebates are available for residential members only.
- Limit one rebate per appliance per Blue Ridge Energy residential account.
- Rebates are based on system efficiency.
- Additional requirements and/or conditions apply.
- Failure to provide required information may result in denial of rebate.
- Blue Ridge reserves the right to amend or discontinue this program without notice.
- Rebates are available for appliances and systems purchased after May 1, 2016.
